

Dear Pastor Brian Goff,

I am writing in the spirit of Paul Revere. As you know it was his display of lanterns in the North Church steeple that helped us win our freedom in the Revolutionary War. I would like to use the church property along I-25 for a similar display of the Combolisk. I have talked with Bob Brooks about this trade agreement but he has not returned my contact. You operated as a corporation. I would like to speak with you regarding the history of deception that forces us to contract as there is a movement to fix errors and to hold people accountable. And since all but one church in Revelation must repent I am hoping you will presents this knowledge to your board and consider learning how our common law is supposed to work that the information may be relayed to your congregation.

It only takes a few questions to realize something isn't right and more important I believe my words come in faith. Did you know that LAW stands for the rules of Land, Air, and Water? I did not. I also did not know that our country delegated its authority to a Scottish corporation to develop the territories and defend us at sea following the Revolutionary War. And are you aware that there are three Constitutions to delegate authority from our sovereign states as nations to the federal States of America, to the TERRITORIAL United States (incorporated) and the MUNICIPAL United States (also incorporated)? The latter two are both in bankruptcy and are for profit government services corporations DBA the United States of America. Said corporations are not only foreign to the land and soil, they are chartered in the CROWN and HOLY SEE.

Our world, its courts, and treaties are set up on the Godly principle of kinds. The living are on the soil and are attached to nonliving entities through the land, which is below the six inches of the soil. The soil gives us national jurisdiction. The water is admiralty and is controlled by the British. The air is controlled by maritime jurisdiction and the Pope through power sharing agreements of the Paris peace treaty. I was unaware until my research into free speech led me to the sovereign movement.

The mainstream confuses this with the "sovereign citizen" movement. You are either a sovereign on the land and soil or you are a Citizen, a legally nonliving asset of the US and USA corps. Your church is, in fact, a corporation set up to force you into international maritime jurisdiction and serve the CROWN and the POPE. All are welcome to the land and soil and can use the 1779 Naturalization Act to declare political status, just like they did following the war, to distinguish from those new Americans and those temporary residents here following the war.

This is important because evil has converted us from naturally being born on the soil as free men and women. At birth we are registered by our birth certificate and we become US citizens in international jurisdiction. This makes us dead entities as defined by Congress. We become presumed lost at sea seven years later when we become another trust in maritime jurisdiction. If you read the 14th Amendment, you realize that we become slave to debt. And as dead entities, charges are brought against you and your family past your normal life. Although these methods have persisted for centuries, our fraud dates to the 1822 secret treaty of Verona when the British King and Pope conspired to act against us to prevent loss of wealth and power. So when I suggest you are not serving a living God, I am suggesting there are no living State Nationals living on the soil in a jurisdiction completely separate from the corporations that have contract all aspects of our lives including our lives. Dead entities, ie corporations, cannot own land and soil by definition of kind. Our forefathers set this up on purpose. The conversion is done without our consent. The sad part is that the Federal government that is supposed to work for us and protect us is actually two for profit Foreign Service Corporations that do not work for us acting in inland piracy in our jurisdiction. They are in breach of contract. Failure to acknowledge this and report the crimes against humanity makes us complicit to the crimes. Thus, not hearing from Bob shows me you do not serve Christ and literally are allowing Caesar to take what is yours. The truth is simply the LAW and history that shows a complicated scheme of fraud, deceit, and crimes

against humanity. Only the People can declare their political status and stand in faith. Will you join us? Will you act like the North Church?

I hope I am wrong. Or at least, let us work together to learn the truth and help the people change their political status to living men and women on the land and soil. We can stand in truth and peace but only if we have education to our numbers and congregations.

The first step in understanding is to research your flag. You fly "Old Glory" which is a specific sized version of the Title IV flag used during war. We have been unlawfully at war since the Civil War as no Congress ever declared it and no treaty ever ended it. The poor communication at the time allowed Abraham Lincoln to become CEO of the United States of America, [Incorporated] and not President of The United States. Were you aware that post offices flew the civil peace flag until the Civil War? Were you even aware that we have a peace flag that has vertical stripes and the opposite colors for the stars and background? Are you willing to fly the peace flag?



We have all been fraudulently taken into international jurisdiction as dead entities. Most of our own military have no idea that they are paid by a British subcontractor. Without common knowledge of the charter of our government corporations, the population does not know that the US Supreme Court even declared itself no different than a Walmart when it, within the corporation, decided it was no different than a corporate nonliving entity in *Clearfield Trust Co. v. United States*. Our employers have learned that they can charge us usury, enslave us, incarcerate us and take our assets. Would you let a Walmart employee do this?

I hope to help people learn the truth with the Combolisk. The Combolisk combines the words community with the word obelisk. This was the first recorded use of an outdoor broadcast structure to inform the public. It shows the inherent right to the land to inform. I would like to enter a trade agreement with you to utilize the corner of your property for displaying a digital Combolisk to the freeway although I will have to start with static faces in order to gain support from sponsors to pay for the digital upgrades to the faces.

Once the digital faces are installed, this will be a great source of communication to the public and a passive revenue stream for the church. Ten percent of the gross would be returned for the right to be on the property. A back to back Combolisk with two faces and up to five sponsors between community messages should soon gross fifty thousand dollars per month. That means five thousand dollars per month to your general fund and we can work together to inform the travelers. The education is the real value as you know. It is a win win as the free broadcasts can direct people to your web site, the Combolisk Project, and the Assemblies of States restoring our unincorporated American government. The structure is not on the same parcel as the church relieving any concern over commerce in the church and Jesus' turning over tables. The access to the Combolisk is across private property of a third party preventing any corporation from removal. The Combolisk is paid for by corporate interests and can be converted 100% to community use during emergencies. Although the candle power is significantly greater today, "one if by Land, Two if by sea," Three if by Combolisk.

Our agreements (not contracts) would insulate and protect us from any interference

As a Christian man of faith and as a believer in our country as a living man, it is critical to build our communication system on the rock of the living church. I just hope you will hear the message that is coming to you. I could locate a few feet in either direction of the church property and the value is lost for the church. Both your neighbors are also corporations and their deeds are tied to the CROWN, not the original land patents granted by the trustees of the treaties. All three Constitutions put treaties above the LAW of the Land in said Constitutions. And there is a process to take your land back to

the land patent so it cannot be taken from you or your congregation if they declare their status and that of their land as was intended.

I have briefly touched on the truth in just a couple pages of text. I have been in the outdoor industry all my life. I have explored the sovereign movement for over six months but realize that there is a lifetime of knowledge that has been kept from us. Eventually we meet the truth and must decide which way to move forward. I guess this is why all but one church in Revelation are tasked with repenting and holding to faith. Let us move forward in faith together as your church is the rock.

Time is of the essence. Much of the world population will be gone in seven years due to the effects of Covid and the vaccine. The patents date to the DOD and thirty years of preparation. Prayer and faith are the only antidote for the destruction of our immune systems. There will be much destruction as many have been tricked into manipulating our mRNA for profit and to declare us genetically modified property of corporations. It is time to fill your seats to capacity and broadcast to the population with your property that fronts the busiest highway in Colorado.

If I do not receive a response to this letter in love within two weeks, I will presume that your church is not led by Christ and will take appropriate actions. Common Law is guaranteed by our Constitutions, which is based on the Bible. Two witnesses are sufficient. A third notice unanswered becomes public LAW. The same Biblical foundation is found in the maxim of international LAW that Notice to Principals is Notice to Agents. Notice to Agents is Notice to Principals. If you are an Acts 2 church you will want to bring this to the living representing your church. This letter will be sent registered and will be published on my site as First Notice. I would also request you get in touch with the Colorado Assembly as they are the lawful unincorporated government in Colorado led by living men and women who have used peaceful and LAWful measures to preserve what was granted to us by the founders of our great nation.
