Dear Sheriff Cooper,

My name is Michael Leigh Macgowan verified through <https://search.americaunincorporated.org/> . My wife Kimberly Ann Peer and I are living men and [wo]men on the land and soil here in Fremont County, as opposed to the COUNTY OF FREMONT, which is the incorporated franchise for which you work. I sent you First Notice on 1/3/23, the text of which can be found here <http://combolisk.org/mikedocs/sheriffremontcolorado.pdf>.

For the record, I do not claim to be a National under USC 8; that Federal code is intended for Federal employees.

I was hoping for an opportunity to work with you regarding living men and [wo]men that have left international jurisdiction of nonliving assets and returned to the jurisdiction of the living on the Land and Soil. Now, as an employer of the Foreign Service corporations, under constitutions of delegated authority, I request specific information from you and your agents by your code, Colorado Open Records Act § 24-72-201 et seq. and/or the Colorado Criminal Justice Records Act § 24-72-301.

First, I would appreciate the log and/or all other data regarding the receipt and acknowledgment of the First Notice I mailed to, you referenced above, with a 1/3/23 autograph date. Please follow the link above if there is any discrepancy to which document I am referring. If you have not received the document, please indicate that as well.

If you have received said First Notice, this Second Notice compels you to follow the LAW and make said Notice to Agents/Principals as no challenge was made to said Notice in common LAW as guaranteed due process on the Land. Please refer to the 6<sup>th</sup> and 7<sup>th</sup> Amendments of your Constitution. Your failure to abide by LAW will serve as evidence and become Public Law as of a Third Notice if you do not provide rebuttal. A response to this Second Notice is expected within two weeks beginning with the return receipt evidence of service.

As a State of State Sheriff, your office requires an Oath of Service. Please provide such notice and evidence that you have taken said oath. Please indicate which Constitutions you uphold.

Please provide data regarding your bond and the provider of said bond as required for your office. A claim will be filed against the bond if there is no evidence that you are making appropriate Notice to Principals and Agents.

Please provide data regarding the charter of your organization and the organization granting said charter. DUNS numbers issued under the authority of the Territorial and Municipal foreign Government Service Providers doing business under the United States, Incorporated, and THE UNITED STATES OF AMERICA, or assignment to similar names, through bankruptcies, and your acts as sub-corporations or other assignments, makes you accountable for your actions. The history of crimes dates back to actions around the Civil War with patterns dating back to the first century. Most of us have been deceived. At some point we must face the truth and act accordingly. Since the patents and exclusions of requirement to certain contractors paints a complete picture of genocide concerning the current “pandemic”, there is no excuse for refusing to research the truth and acting accordingly.

Governor Polis was Noticed three times by the Colorado Assembly. Among other things, said Public Law indicates a fee schedule for certain actions, including misidentification of Colorado State Nationals as US or USA Citizens. Please provide data regarding your service or lack thereof. Since the Idaho Assembly, the Federation of States, Anna Maria Reitzinger as fiduciary and James Clinton Belcher of Head of State of the unincorporated American government on the land and soil have been identified internationally, you will be complicit for failure to forward said Notice to Agents and Principals now that you have been made aware. Once you have validated said Notice, you will be compelled to honor it in Common LAW of the land and soil. The response to this lawful request will serve as evidence to submit to the Jural Assembly. If said Governor has failed in his fiduciary responsibilities, you are expected to uphold the Public LAW and arrest anyone, including the governor, if served with evidence of a judgment and civil orders.
